OFFICE MEMORANDUM

Sub: Document Verification of candidates selected through Staff Selection Commission, **Combined Graduate Level Examination, 2021** to the post of **Tax Assistant** in CBDT and allocated to the charge of **Principal Chief Commissioner of Income Tax, West Bengal & Sikkim**-- matter regarding.

Please refer to the above.

It is intimated that your name has been recommended by the Staff Selection Commission for appointment to the post of **Tax Assistant** in the Income Tax Department, West Bengal & Sikkim region including Port Blair. It may be kept in mind that you may be posted anywhere in this charge and are liable to be transferred any time anywhere within the charge (i.e. West Bengal & Sikkim region including Port Blair) under the jurisdiction of the Principal Chief Commissioner of Income Tax, W.B. & Sikkim. If you are willing to be posted as **Tax Assistant** in this region, you may fill up the following documents mentioned here under :


- (i) **Blank Attestation Forms** (enclosed in **triplicate**) with a recent passport size photo to be pasted on the first page at the top left corner earmarked in all the three Attestation Forms (totalling to 3) and return these forms to this office for necessary Police Verification. **The items and columns of the Attestation Form should be filled in very legibly. All of them are mandatory and no item of the Forms should be kept blank;**
- (ii) **Medical certificate of fitness** in the prescribed Form 'A' along with statement in Form 'A-I' from any of the following authorities:
 - (a) **In the case of male candidate** -A Civil Surgeon or a District Medical Officer or a Medical Officer of equivalent rank,
 - (b) **In the case of female candidate** -A Registered female medical practitioner possessing a medical qualification included in one of the schedules to the Indian Medical Council Act, 1956 (102 of 1956), Indian Medical Central Act, 1970 and Homoeopathy Central Council Act, 1973.
 - (c) Those who have already in the Government service and are going to opt for technical resignation from his previous service, may submit the attested copies of Medical Certificate which he/she had already furnished in his/her previous employer at the time of appointment, if needed.

- (iii) **FORM 'B'** :-Two Certificates of good character in the (enclosed) prescribed form i.e. (Form 'B') from two Gazetted Officers of the Central or State Government or one such certificate from a Stipendiary Magistrate, not related with the appointee by birth or marriage
- (iv) Original certificates in proof of academic and other qualifications, date of birth, caste certificate, certificate of PwBD (erstwhile PH) in case of PwBD (erstwhile PH) category, ID Proof (Aadhar Card/ Voter Card etc.), Pension Papers in case of Ex-Serviceman and Registration card of Employment Exchange (in original), NOC from your previous employer (in case of serving as a Government Servant), affidavit regarding mistake in name/title etc. should be produced. **Coloured Photocopies of the same duly attested by a Gazetted officer should also be submitted.**
- (v) **FORM 'C'**:- The appointee must furnish a statement in the prescribed form (Form 'C') (enclosed) giving full particulars of his previous employment, if any, for the last three years under the Govt. of India or under any State Government.
- (vi) **FORM 'G'** :- Before joining, the appointee must give a declaration in the prescribed form (enclosed) to the effect that he/she does not have more than one wife/husband living.
- (vii) A certificate in the enclosed prescribed form will have to be produced by an appointee in support of the claim, if any, for being treated as a member of Scheduled Castes/Scheduled Tribes (**Annexure-II**) & OBC Community (**OBC Certificate Format**). Further, the appointment is subject to following condition in respect of the candidates belonging to the OBC category:
- (a) **A person seeking appointment on the basis of reservation to OBCs must ensure that he/she possesses the caste/community certificate and does not fall in creamy layer. Further, he/she requires to submit the caste certificate (OBC) for current year (i.e. 2022) as per DoPT's OM No. 36036/2/2013-Estt.(Res-1) dated 31st March 2016. The crucial date for this purpose will be the closing date for receipt of online application i.e. 23.01.2022.**
- (viii) (a) **EWS** :-An Income and Asset Certificate in the enclosed prescribed format (**Annexure-I**) will have to be produced by an appointee in support of the claim, if any, for being treated as a member of Economically Weaker Sections(EWS) category. The Income and Asset certificate by any one of the following authorities shall only be accepted:-
- (i) District Magistrate /Additional District Magistrate/ Collector/ Dy. Commissioner/ Addl. Deputy Commissioner/ First Class Stipendiary Magistrate/ Sub-Divisional Magistrate/ Taluka Magistrate/Executive Magistrate/Extra Assistant Commissioner,
- (ii) Chief Presidency Magistrate/Addl. Chief Presidency Magistrate/ Presidency Magistrate,
- (iii) Revenue Officer not below the rank of Tehsildar and
- (iv) Sub-Divisional Officer of the area where the candidate and/or his family normally resides.
- (b) The Income and Asset Certificate shall pertain to the Financial Year prior to the year of application,
- (c) The crucial date for submitting Income and Asset Certificate by the candidate may be treated as the closing date for receipt of application for the post i.e. **23.01.2022.**

- (ix) If the appointee is a subject of Nepal or a resident of Union Territories of Pondicherry, Daman and Diu or a resident of Andaman & Nicobar Islands or of Indian Origin repatriated from Ceylon/Burma and migrated to India or of Indian Origin migrated from Kenya, Uganda and the United Republic of Tanzania, a certificate to that effect must be produced at the time of joining.

In this regard, the candidates figuring in **Annexure 'A'** are directed to submit all relevant forms, duly filled in & original documents (as applicable) and report for Document Verification on the dates mentioned against their names at the **O/o the Addl. Commissioner of Income Tax, W.B & Sikkim, 1st Floor, Room No.- 14, Aayakar Bhawan, P-7, Chowringhee Square, Kolkata-700069**, failing which it will be presumed that you are not willing to be appointed as **Tax Assistant** in the Income Tax Department, West Bengal & Sikkim Region. Please note that filling up of the Forms does not necessarily mean that you will be offered appointment to the post of **Tax Assistant** in the Department.


